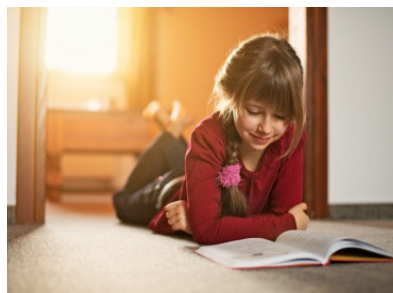

Types of life insurance include:

WHOLE LIFE

Permanent policy which gives you guaranteed protection for your loved ones that lasts a lifetime. With whole life insurance, you earn guaranteed cash value, which you can use to help replace a family's loss of income, emergencies, or to leave a legacy for the next generation.

UNIVERSAL LIFE

Permanent life insurance that provides a guaranteed death benefit plus the opportunity for cash value buildup similar to the savings element in whole life insurance. Cash value can be accessed through income tax-free loans and withdrawals.
