<b>Interest Rate Lock-In Procedures for Premium</b>	<p>Interest Rate Lock-In will be the greater of:</p> <ol style="list-style-type: none"> <li>1) the first year annual yield rate in effect on the date the client signs the application, or</li> <li>2) the first year annual yield rate in effect on the date the funds arrive in the Principal home office (h.o.)</li> </ol> <p>Applications and funds must be received in the h.o. within 14 calendar days following the client's signature date on the application or the client will receive the current initial base interest rate in effect at the time the funds are received in the h.o.</p>

<b>Interest Rate Lock-In Procedures for Premium - 1035 Exchanges/Rollovers/Direct Transfers</b>	<p>Interest Rate Lock-In will be the greater of:</p> <ol style="list-style-type: none"> <li>1) the first year annual yield rate in effect on the date the client signs the application, or</li> <li>2) the first year annual yield rate in effect on the date the funds arrive in the Principal home office (h.o.)</li> </ol> <p>Applications must be received in the h.o. within 14 calendar days following the client's signature date on the application and funds must be received in the h.o. within 60 calendar days following the application signature date or the client will receive the current initial base interest rate in effect at the time the funds are received.</p>
