

New Platinum Assure 5 Rate Effective December 7, 2020

Americo will be lowering the interest rate on our Platinum Assure 5 fixed annuity. The deadline to lock in current rate is December 4, 2020.

Applications and money must be received in the Home Office by December 4, 2020, 5:00 P.M., Central, in order to lock in current rates.

All funds on applications received by end of day on December 4, 2020, must be received in the Home Office no later than January 18, 2021, 5:00 P.M., Central, to receive the current rate.
