Revised PruLife Founders Plus UL Supplement – 03/01/2021

Effective Monday, March 1, 2021, the *Pru Founders Plus Supplement* (ORD 96200-2020 PFP) will be revised to include the new Goldman Sachs Voyager Indexed Account. A new *Pru Founders Plus Disclosure* (ORD 115809-2020 PFP) will be introduced for use with the revised product. Please refer to the Ready to Sell List for state approval information.

Revised Pru Founders Plus Supplement

The *Pru Founders Plus Supplement* (ORD 96200-2020 PFP) has been revised as follows and will be used with the December 2020 Pru Founders Plus product with issue basis 307 and 306:

1. Rename the "Plus 100 Account" to "S&P 500® Indexed Account".
2. Add the "Goldman Sachs Voyager Indexed Account".
3. Add transfer options in the "Designated Transfers (Optional)" section.
4. Introduce state-specific forms for the following states:
 - **Alabama** (ORD 96200-2020 PFP AL)
 - **Arkansas, District of Columbia, and Rhode Island** (ORD 96200-2020 PFP AR, DC, RI)
 - **Colorado** (ORD 96200-2020 PFP CO)
 - **Florida** (ORD 96200-2020 PFP FL)
 - **Hawaii, Louisiana, New Mexico, Tennessee, Washington** (ORD 96200-2020 PFP HI, LA, NM, TN, WA)
 - **Maryland** (ORD 96200-2020 PFP MD)
 - **Maine** (ORD 96200-2020 PFP ME)
 - **New Jersey** (ORD 96200-2020 PFP NJ)
 - **New York** (ORD 96200-2020 PFP NY)
 - **Pennsylvania** (ORD 96200-2020 PFP PA)
 - **Virginia** (ORD 96200-2020 PFP VA)
5. The forms will carry a revision date of 2020.

When submitting the long application, the Supplement must be completed when applying for the December 2020 Pru Founders Plus product with issue basis 307 and 306.

When submitting the Worksheet, please complete section O, subsection 1B and the Supplement will be included in the policy at issue.

New Pru Founders Plus Disclosure

The new Pru Founders Plus Disclosure will carry form number ORD 115809-2020 PFP. This form must be completed when submitting the long application or the worksheet.
