Required New Business items

- Annuity application (state-specific if applicable)
- State-required forms and notices (in appropriate states)
- Owner acknowledgment form (all states)
- AGL/US Life Client Profile form
- Reg 60 paperwork (New York only)
- Premium (payable to appropriate issuing company —no money orders or traveler’s checks)
- Replacement notice form
- 1035 Exchange/Trustee Transfer form with original signatures
- Signature Attestation form submitted within 30 days of contract issue. Otherwise, an original signed Replacement form, Transfer form, or a Signature Guarantee on a financial transaction form is required for any financial transaction request.
- Proof that non-natural owner has authorization to sign (ex: Corporate Resolution, Certification of Trust (COT), Power of Attorney (POA) less than one year old).
