



New AIG Lockbox Requirement for IMO/BGA Annuity Premiums

Thank you for your partnership and continued confidence in AIG. There has been an important procedural change that may require you to update the mailing address you use to send in annuity premiums.

Effective **November 30, 2021**, our lockbox provider, JPM Chase Bank, will no longer accept U.S. Post Office mail or courier packages (UPS, FedEx, etc.) that are missing a lockbox number from the address label. Going forward, if a lockbox number is missing, the package will be returned to the sender.

The chart below provides all the up-to-date information you may need to ensure that there are no delays with getting your clients' policies funded. **The lockbox numbers are in bold.** All forms which reference these addresses will be updated by mid-November.

Please note that several other annuity companies that send us transfers have also been advised of this change.
