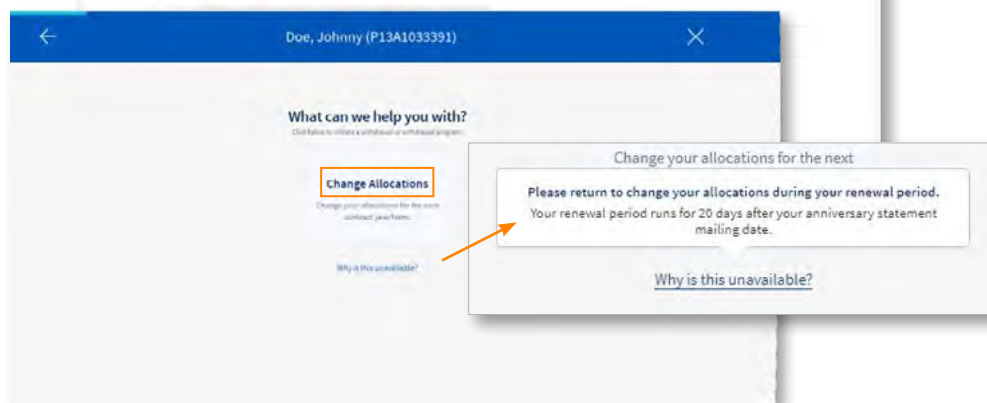
You also have the option to change index account allocations from Connex.
