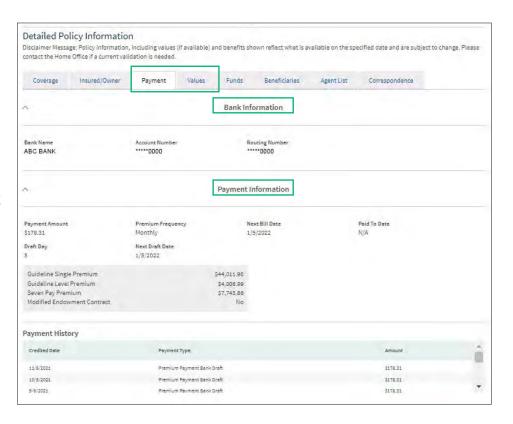
Connext for **Inforce**: Tips for policy management and transactions

Our producer portal **Connext** offers several ways to help stay on top of your inforce business, access policy documents and save time with self-service features, including ...

Enhanced payment and value details

The Payment and Values tabs found within the Policy Details section now put more critical information at your fingertips, including:

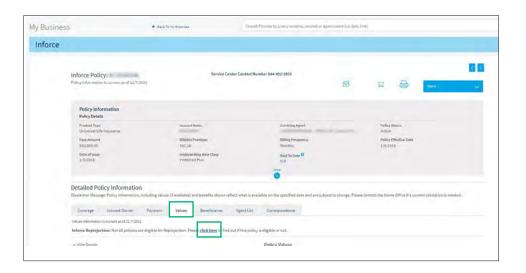
- Banking Information (if premiums are drafted)
- Payment and billing info including next billing and draft date
- · Payment history
- Payment declines, including decline date and reason
- Accumulation and surrender values (if applicable)
- · Funds (for IUL and VUL policies)
- To access: Find the policy in the Inforce section of the My Business dashboard, click on the policy, and then click the button under the Values tab.



Access WinFlex Inforce reprojections with one click

When logged into Connext, bypass the WinFlex sign-in and go straight to a reprojection screen for the policy with key details already filled in. More than 100 products are now available for self-service reprojections.

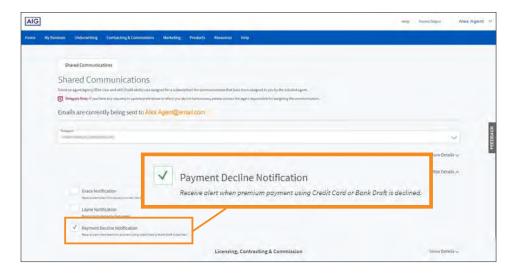
- To access: Find the policy in the Inforce section of the My Business dashboard, and click the "Click Here" link under the Values tab

Get notifications of payment declines, including decline date and reason

Sign up for email notifications which are generated and sent daily.

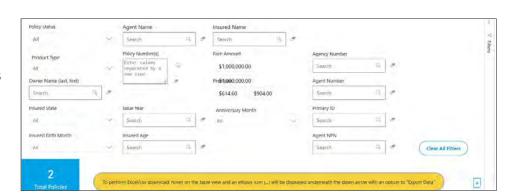
 To enable: In Notification Settings (located under your name in the top right corner), check the Payment Declines box under Inforce notifications.



Download reports for your inforce business

Includes sorting and filtering options for data such as premium, face amount and issue year.

- To run a report: Two options depending on the level of detail you need – through My Business dashboard (basic information) or using the Inforce Download Report option (more details).
