### Solution

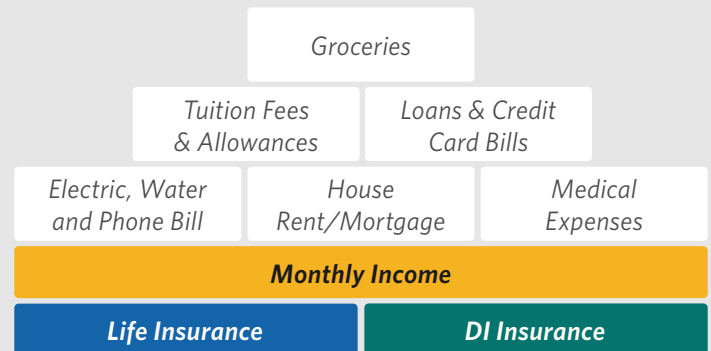
