

New Annuity Rates Effective February 1, 2023

The deadline to lock in current rates is January 31, 2023.

Applications and money must be received in the Home Office by January 31, 2023, 5:00 P.M., Central, in order to lock in current rates.

All funds on applications received by end of day on January 31, 2023, must be received in the Home Office no later than March 17, 2023, 5:00 P.M., Central, to receive the current rates.

Rates in **RED** indicate a decrease from the previous rate.

Rates are current as of February 1, 2023, and are subject to change.
