## New Annuity Rates Effective April 28, 2023

Americo has made some rate adjustments to our annuity products. New contracts issued on or after April 28, 2023, will receive the new rate.

To lock in current rates, applications must be received in the Home Office by April 27, 2023, 5:00 P.M., Central.

All funds on applications received by end of day on April 27, 2023, must be received in the Home Office no later than June 12, 2023, 5:00 P.M., Central, to receive the current rates.

Rates in GREEN indicate an increase from the previous rate and rates in RED indicate an decrease.
