

## New Annuity Rates Effective September 27, 2023

Americo has made some rate adjustments to our annuity products. New contracts issued on or after September 27, 2023, will receive the new rate.

To lock in current rates, applications must be received in the Home Office by September 26, 2023, 5:00 P.M., Central.

All funds on applications received by end of day on September 26, 2023, must be received in the Home Office no later than November 10, 2023, 5:00 P.M., Central, to receive the current rates.

Rates in **GREEN** indicate an increase from the previous rate and rates in **RED** indicate a decrease.
