October 2023 Index Account Updates

At Prudential, we are committed to maintaining financial discipline and continue to review impacts to the various index accounts offered on currently sold and no longer sold products. Overall higher hedging costs associated with capped accounts caused decreases, while uncapped accounts had lower hedge costs and were improved (spreads reduced).

These changes will be effective for index segments starting October 15, 2023. Please see below for the complete list.

A letter will be sent to policy owners when there are changes to index accounts, informing them of the new caps, rates and spreads, and that the future segments will be impacted. The letter also indicates that these changes may result in different values than were shown in their most recent illustration and how they can request a current illustration.
