

Allocation change guide North American fixed index annuities

1. After logging into the **NorthAmericanCompany.com** agent website, navigate to My Business > Inforce Contract Access.
2. Search for the contract on which you wish to make an allocation change.
3. Click on “Allocations” in left navigation under “Inforce Business Search” and a new window will open.
4. Click “Make Changes” at the bottom right and the new allocation column will be activated for you to make the allocation changes desired. **Changes are only allowed 30 days following the contract anniversary.**
