Summary: Effective immediately, new policy service forms are available for individual disability income policies in states that have approved Dlnamic Cornerstone Income Protection<sup>®</sup>. This change does not apply to policyholders in states where Dlnamic Foundation is being sold or policyholders with Dlnamic Fundamental<sup>®</sup> policies. The revision is highlighted below.

The new forms must be used for servicing policyholders with individual DI or Business Overhead Expense policies, even if these policies were issued under a prior DI product series (DInamic 2000 or DInamic Foundation).


